

**NOTICE OF SPECIAL DISTRICT ELECTION
CADYVILLE FIRE DISTRICT
IN THE TOWNS OF PLATTSBURGH AND SCHUYLER FALLS,
COUNTY OF CLINTON, STATE OF NEW YORK**

NOTICE IS HEREBY GIVEN that pursuant to a resolution and a bond resolution of the Board of Fire Commissioners of Cadyville Fire District, in the Towns of Plattsburgh and Schuyler Falls, County of Clinton, State of New York, adopted on February 25, 2019, a Special District Election of the qualified voters of said Fire District will be held on April 2, 2019 at 6 o'clock P.M. (Prevailing Time). The polls will remain open from 6 o'clock P.M. to 9 o'clock P.M. (Prevailing Time) and as much longer as may be necessary to enable the voters then present to cast their ballots at the Fire House, located at 2122 Route 3, Cadyville, New York 12918 for the purpose of voting upon the Proposition stated below.

The voting will be by separate ballot on voting machines in the manner provided by the Town Law and shall be for the following:

PROPOSITION

RESOLVED:

(a) That the Board of Fire Commissioners of Cadyville Fire District, in the Towns of Plattsburgh and Schuyler Falls, County of Clinton, State of New York (the "Fire District"), is authorized to finance the additional costs to acquire, construct and reconstruct the additions, renovations and improvements to the existing Fire House, in and for the Fire District, including all necessary original furnishings, equipment, machinery and apparatus there for, preliminary costs and costs incidental thereto and the financing thereof, and to expend there for an amount not to exceed the estimated total cost of \$210,000; and

(b) That \$210,000 of moneys held by the Fire District be appropriated and applied to pay a portion of the costs of such purpose; and

(c) That a tax is hereby voted in an amount of not to exceed \$210,000 to finance said cost, such tax to be levied by and collected in installments in such years and in such amounts as shall be determined by said Board of Fire Commissioners; and

(d) That in anticipation of said tax, serial bonds of the Fire District are hereby authorized to be issued in the aggregate principal amount of not to exceed \$210,000 and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable.

Such Proposition shall appear on the ballot label to be inserted in the voting machines used for voting at said Special District Election in substantially the following form:

RESOLVED:

(a) Should the Board of Fire Commissioners of Cadyville Fire District, in the Towns of Plattsburgh and Schuyler Falls, County of Clinton, State of New York (the "Fire District"), be authorized to finance the additional costs to acquire, construct and reconstruct the additions, renovations and improvements to the existing Fire House, in and for the Fire District, including all necessary original furnishings, equipment, machinery and apparatus therefor, preliminary costs and costs incidental thereto and the financing thereof, and to expend therefor an amount not to exceed the estimated total cost of \$210,000 and (b) that a tax be voted in an amount of not to exceed \$210,000 to finance said cost, such tax to be levied by and collected in installments in such years and in such amounts as shall be determined by said Board of Fire Commissioners?

NOTICE IS FURTHER GIVEN THAT a qualified voter for said Special District Election is one who is a (1) citizen of the United States of America, (2) eighteen years of age or older, and (3) a registered voter and resident within the Fire District for a period of thirty (30) days next preceding the Special District Election.
